#### **NRPA AFO Webinar Format**

Register for a Live online NRPA AFO webinar-(\$365). You must register in advance- so I can ship the books and materials for arrival to you before class.

This webinar will be 2 days approximately 6-8 hours each day with a 30 minute break. You must have a webcam and microphone. I must see that you are present and I must be able to watch you take the exam. If I cannot verify that I observed you take the class and complete test, then you will not be certified- regardless of your test score!

This webinar will include much important information including digitally the handouts from an in-person class, review of calculations, and review for the exam.

During the Live online webinar, you will be able to ask questions- either by chat or during some periods, with your microphone, by voice.

This live Webinar will be run almost the same as a normal 2 day class. In addition to the calculations and other information that you need to know for the test, there is an emphasis on the VGB act and related safety issues that are crucial for the safety of your pool.

Following the Webinar Review, the exam will be available online in a third Zoom meeting available after you have completed the 2 day Webinar.

# Texas Electrical License RAIL UPDATE! Announcements from TDLR!

- 1. Phishing scam asking recipients to validate information appears to target TDLR licensees
- 2. On November 23, 2020, the Texas Commission of Licensing and Regulation passed an emergency rule in response to the ongoing COVID-19 pandemic.

Pursuant to the new rule, all TDLR licensees with a renewable license that expired between August 1, 2020, and November 30, 2020, are considered to hold an emergency license valid for up to 120 days after their license expiration date-HOWEVER- YOU MUST Renew on Time!- TDLR is just way behind processing the renewals. So, the new cards may not be sent out in a timely manner- so, if you have properly renewed your license, you are covered by the emergency provisionbut you still must handle your renewal **ON-TIME! 1/1/2021 Update!** I just received my 2021 license renewal from online- simple, easy, fast- and I received my new card in less than 2 weeks- during CoViD and During the

TDLR announced that they did adopt the 2020 NEC November 1. The RAIL Exam changed November 1, and all electrical work should meet the requirements for the 2020 NEC code!- For people that are licensed-

## PHTA/NSPF CPO 100% online classes!



The CPO (Certified Pool Operator Course) will now be available for a

limited time as a 100% Online class. This program will not fit for everyone, but the online option is available.

Some states are trying to rollback acceptance of the Online Only class- Watch for updates! If you are not sure-

Please call your local Health Department.

There are 3 parts to the program

Step 1-The online class- Pool Operator Primer (\$225/person) has always been available as part of the Fusion option. For this portion, when you register on my website, I send the access codes for your online class- and you have access to an online version of the book. So, you can start the online Pool Operator Primer as soon as you receive the email with the access codes. I also mail you a copy of the Book and Handouts.

Step 2, you must register for an online real-time webinar. (\$140). The webinar will be conducted just like the review for the class- with an emphasis on some of the safety issues like VGB Act and also the calculations necessary for the test. I expect the webinar to last about 6 hours. During the webinar, you will be able to ask questions either from your computer microphone or by text. Live & Real-time-I will answer your questions as you ask them.

The \$140 includes the webinar and the additional cost of the online exam. PHTA is raising costs January 1

That brings the total to \$365/person

I have created a PowerPoint presentation specifically for for the CPO review.

#### Step 3- ONLINE EXAM.

For the webinar and the test. The participant MUST have a computer that provides a video and audio access to Zoom.

Before they can take the webinar, they MUST complete the online Pool Operator Primer Course.

## Free!!! NEC Code Update- Free

Check out update classes listed above.

The Texas Residential Appliance Installer License (RAIL) is required for repairing or replacing swimming pool and spa electrical equipment-including Pumps, Heaters, Lights, Time clocks/automation, salt water systems, etc. **The fines are \$2000/ offense.** 

RAIL Prep Classes with the 2020 NEC Code have begun- the next class is Thursday, February 18



I look forward to starting inperson Classroom classes, probably beginning late in April, 2021!!! Please stay healthy.



When they log onto the webinar, I will need to see their Certificate of Completion.

Before the test, I must see their Picture ID.

After the Webinar, They will be able to log onto an online exam- but they MUST have the webcam on them while they are taking the test. If I cannot witness the exam, they will not be certified- regardless of their score.
